Golf Course architects Stephen Kay and Golf Digest Architectural Editor Ron Whitten handpicked the premier architects from 1885 and 1955; seventy years of great design. Kay, Whitten and lead shaper Dennis Turco utilized shapes of tees, contours of greens, bunkering and strategic hole layouts to pattern the style of each architect. Our history lesson begins with Old Tom Morris, who designed such treasures as Carnoustie and Murifield in Scotland and the New Course and Jubilee at St. Andrews. The second hole reflects C.B. Macdonald, the founding father of American golf course architecture, who laid out America's first 18-holes of golf. Macdonald designed The Chicago Golf Club in 1895 and later created the masterpiece known as National Golf Links of America on Long Island, New York. In addition The Architects Golf Club features holes patterned after other great names including A.W. Tillinghast, Donald Ross and Alister MacKenzie to name a few. The final chapter was reserved for Robert Trent Jones Sr., commonly regarded as the most influential architect in the history of golf.

Lawrence and Dennis Turco, owners and operators of Turco Golf Inc., helped make The Architects Golf Club dream a reality, building the club from the ground up and making it the regions best semi-private facility. In 2007 The Architects Golf Club added a state of the art sixteen thousand square foot clubhouse. Membership Terms and Payment Authorization

1. Approval for Membership Privileges: I hereby apply for membership privileges at The Architects Golf Club. Membership is contingent upon approval, which approval shall be in the Club's sole and absolute discretion.
2. Term of Membership: Membership in the Club is an annual membership continuing for one year from the date of acceptance by the Club. Members are required to give written notice 30 days prior to the expiration for the membership to be terminated. Unless written notice is received, membership shall renew automatically one year from the date of acceptance at 2009 rates.
3. Membership Privileges in the Club: No Ownership of Club. The undersigned hereby acknowledges that the Club Facilities are owned and operated by the Club and that membership in the Club permits the Club Member to use the Club Facilities, but is not an investment in the Club, nor does membership confer on the Club Member any equity or ownership interest or any other property in the Club or Club Facilities. Membership in the Club is a revocable license, subject to suspension and revocation with or without cause by the Club.
4. Membership Fees: The undersigned acknowledges and agrees that this Application for Membership Privileges and accompanying payment are irrevocable by the applicant after they have been mailed or delivered to the Club, unless this Application for Membership Privileges is not acted upon favorably. All membership fees are non-refundable, and failure to pay all amounts of the membership fee when due will be cause for forfeiture of membership privileges in the Club without refund of any membership fee previously paid.
5. Terms for Payment: By signing below, the member expressly grants the Architects Club the authority to charge the credit card listed below on the dates listed below. The member understands that the membership dues are due in full before playing. The member understands that the membership dues are non-refundable for any reason and hereby waives any rights to dispute any of the membership dues charged to their credit card, as listed below. If the credit card is declined for any reason, the unpaid balance will become due in full and the member may be prohibited from playing until payment is made. The member agrees to reimburse The Architects Club for any legal and court fees incurred to collect any unpaid membership fees.

6. Membership No show and Short Show Rules: All memberships are subject to the rules and regulations of the Club regarding no-show and short-show tee times. Failure to abide by Club policy regarding no-show and short-show tee times will result in charges to a member Visa, MasterCard or American Express account on the day of short show or no show.
7. Bag Storage Fee - All members without exclusion shall have the opportunity to store their bags onsite for an annual fee of \$125.

Member Rules and Regulations

Overview

- A. This document serves as notice to all members, current and future of The Architects Golf Club, as written rules and regulations for membership in the club.
- B. Ownership of The Architects Golf Club reserves the right to add, delete or modify any part of this document as deemed appropriate by their decision. Current members will be notified in writing of any and all changes prior to fifteen days of the effective date for changes.
- C. Guests of members are held to the following rules and regulations for members. All members are responsible for the actions of their guests while on club property. Members will be held financially liable for any damage and/or theft of club property caused or committed by their guests.
- D. Severability-If any part or portion of this document is deemed unenforceable by governing or legal entities, then the remaining part or portion will continue in effect.

Golf Rules

- A. Dress Code- Appropriate golf attire must be worn at all times. Jeans (denim), tee shirts, bathing or gym shorts, tank tops and halter-tops are not permitted. Golf shirts (men and ladies) must be in current style as worn by PGA and LPGA members. Hats must be worn with the bill facing forward at all times. Athletic, non-descript warm-up suits may be worn in cooler and inclement weather. Additionally, not only must appropriate attire be worn at all times, but it is necessary to observe the spirit of the dress code. Any member wearing golf attire deemed to be inappropriate by the General Manager, Golf Professional or Manager on duty will be asked to change such attire or leave the club. Inappropriate attire would include but is not limited to articles of clothing in poor repair, shorts that are too short or too long, clothing with offensive graphics, writings or messages, etc.
- B. Portable Cellular Phones - The Architects Golf Club encourages all members to leave their cell phones in their cars or lockers. However, if you must have phone accessibility, please set your phone to vibrate mode while in all playing or practice areas. Use of speakerphone or walkie-talkie features is strictly prohibited.

C. Rules and Etiquette- USGA Rules will govern play at all times, unless otherwise noted and posted in the Golf Shop. Local rules are noted on the official score card of The Architects Golf Club. The Golf Professional and his/her staff will be pleased to assist with rulings. The traditional rules of golf etiquette are applicable at all times. Please respect our course by properly repairing all ball marks and filling fairway divots. A golf etiquette brochure will be available to all members in the Golf Shop. The brochure includes, but is not limited to; care of the greens, bunkers, fairways, slow play, cart use, “playing through”, and other acceptable behavior, to ensure an enjoyable and relaxing game of golf. Practice is restricted to practice areas only unless it occurs during an on-course golf lesson given by the club’s teaching professional. Violations of these rules may result in suspension or loss of playing privileges at the discretion of the General Manager, Golf Professional or Ownership.

Conduct

A. All members are expected to maintain proper decorum while on premises at the club. At the discretion of the Owners, General Manager, Golf Professional or Manager on duty, members who do not maintain a proper civil and social attitude will be asked to immediately leave the premises.

B. Alcoholic beverages- The Architects Club serves alcoholic beverages under a license issued from the State of New Jersey. Members are restricted from bringing alcohol for on-site consumption onto club property. No alcoholic beverages are to be served to or consumed by anyone under the age of 21 anywhere on club premises. Persons who are unable to verify their age may be denied service. Club employees may, at their discretion, refuse to serve alcoholic beverages to any person who appears to be intoxicated.

Indebtedness to the Club

A. Membership fees- Membership fees must be paid in accordance with the respective Membership Agreement between the member and The Architects Golf Club. Playing privileges and clubhouse signing privileges will be suspended immediately if membership fees become delinquent. Members who enter into a payment plan or request signing privileges will be required to have on file two valid credit cards with current expiration dates and a signed form authorizing The Architects Golf Club to charge the primary card for the payment due on the assigned date.

B. Monthly charges- All member accounts for “signing” privileges will be settled with an automatic credit card payment on the first day of the month for charges made during the previous month. In the event the credit card payment is declined, the Architects Club will promptly notify the member of such decline and suspend playing and signing privileges until the balance is settled. An additional \$10.00 administrative fee will be assessed if the credit card payment is declined.

C. Signing privileges- At the request of the member, The Architects Golf Club will complete a credit check prior to affording a member signing privileges. A satisfactory report is required for granting signing privileges to the member. The Architects Golf Club reserves the right to cancel signing privileges to any member or members with proper written notification five days prior to the cancellation date.

D. Monthly service fees- All monthly member charge accounts, whether for membership fees or signing privileges, will be subject to a \$10.00 monthly administrative fee. Any member with signing or fee payment plans may notify The Architects Golf Club no later than thirty days from the effective date if they wish to have their signing privileges revoked. On the effective date, all charges will be settled with the credit card on file and signing privileges will be revoked.
